Hedcor marks

35th year

Hedcor, Inc., a fully-owned subsidiary of Aboitiz Power Corporation, recently celebrated its 35th anniversary. The company is the leading run-of-river hydropower plant developer and operator in the Philippines.

Hedcor began operating in 1978 for the then National Power Corporation–owned Lower Talomo hydropower plants in Davao City. In 1985, it assumed operation and maintenance of the Asin hydropower plants owned by the City of Baguio.

The first Hedcor-built hydropower plant was constructed in Benguet in 1988. The company has since grown into a powerhouse with a portfolio of 19 power plants for a combined capacity of 155 megawatts (MW), making Hedcor the largest developer of run-of-river plants in the Philippines.

Run-of-river hydropower is a type of renewable energy that utilizes the natural

flow and elevation drop of a river to generate electricity. A portion of the water from the river is diverted into a conveyance pipe that channels the water through a desander removing and cleaning out any impurities of the water before entering the turbine to generate electricity. Once the electricity has been produced, the water is directed back to the waterway's existing river flow.

Hedcor is a reliable partner of its host communities. To date, the company has provided education to 19 scholars and constructed five school buildings, including three under the Aklat, Gabay, Aruga tungo sa Pag-angat at Pag-asa (AGAPP) Program.

Hedcor complies with Energy Regulation 1–94, a government mandate requiring power generating companies to give back one centavo for every kilowatt–hour (KWh) sold. Host communities have availed of over P20 million

worth of benefits to fund electrification, development and livelihood, and reforestation, watershed management, health and environmental enhancement projects.

In 2001, Hedcor launched Cleanergy, an initiative that promotes the generation and use of renewable energy. Today, Cleanergy is AboitizPower's brand for clean and renewable energy. With a vision of generating two billion kWhs of Cleanergy by 2020, Hedcor is steadily increasing its work force to support its expansion plans to achieve this goal.

"Hedcor is committed not only to maintaining its leadership in the field of run-of-river hydropower, but also to improving the lives of the residents of our host communities," said Hedcor President and Chief Operating Officer Rene Ronquillo. "As our company grows, it is important that our host communities grow with us."

The company is recognized as one of the the top employers in the country today, winning accolades such as the Gawad Kaligtasan and Kalusugan Award for Occupational Safety and Health from the Department of Labor (DOLE) and the Safety Milestone Award from the Bureau of Working Conditions. Recently, DOLE awarded the company with the Tripartite Certificate of Compliance with Labor Standards.

The Employers Confederation of the Philippines also recognized Hedcor with the Industrial Peace and Harmony Award in the Kapatiran Sa Industriya or KAPATID awards which is conducted every two years. This is the second consecutive KAPATID award for Hedcor.

Hedcor is OHSAS 18001:2007 certified – the international standard for Occupational Health and Safety Systems.

Ongoing expansion projects include the Tudaya Hydroelectric Project in Davao del Sur and the upcoming completion of the Sabangan Hydroelectric Power Project—Hedcor's first in the Mountain Province.

Ronquillo added, "There are projects in Bukidnon, Negros and other parts of the Cordilleras. We believe there's strong community support because the nice thing about small hydro is that it provides inclusive growth and inclusive development in the communities."

Host communities grow along with Hedcor

The Bagobo-Tagabawa, an indigenous peoples (IP) community in Sibulan, Davao del Sur, has noted an improvement in their quality of living since Hedcor started operating in their area. The IP group has since benefited from social development projects as well as an annual share in the generation of Hedcor's 42.5–MW Sibulan Hydroelectric Power Plant.

Lydia Ang, a community leader in Sibulan, recalled how they had to endure hard living conditions before Hedcor developed the Sibulan plants: a community without farm-to-market roads, difficulty of reaching hospitals, limited access to clean water, dilapidated school facilities and lack of educational materials for students and teachers alike.

"We received many benefits from Hedcor," Ang said, adding that the community's annual budget tripled within the Hedcor's first year of operations. Ang also said community leaders are tasked to look for qualified residents who could be endorsed for employment with Hedcor.

Hedcor Vice President for Business Development Gregorio Jabonillo said they always make sure that the growth of host communities is inclusive with that of the company's.

Host communities each receive an annual share from the company's power generation. This is the third year that communities in Sibulan received their annual generation shares, which leaders used to provide the needs of their constituents.

Local property owners also benefit from rentals for Hedcor's use of their land. Payments are made twice a year and given six months in advance. For some land owners in Sibulan and Tudaya, the rentals made it possible to send their children to school.

To boost livelihood, the company gave free workshops for local farmers to increase production through better management of fruits and vegetable crops. They have also been given valuable insight into new trends in agriculture.

To further help the local agricultural source of revenue, a total of 48 kilometers of farm-to-market roads were developed by the company. This includes a P2.2 million bridge in Tudaya. With the ongoing construction of Tudaya Hydropower Plant, another 6 kilometers of roads will benefit the local community.

In addition to its efforts in protecting the environment, Hedcor's tree planting programs extend beyond its adopted area of the Mt Apo Natural Park. Sibulan tribal leader Datu Gideon Manapol said that landowners could request what kind of fruit trees the company would plant. He added that the landowners can later earn income from these fruit bearing trees.

Most of the benefits the community receives from the company are on top what the law requires. Nonetheless, the host communities still benefit from Hedcor's other corporate social responsibility projects focused on education, health and livelihood.



With the construction of Hedcor's Tudaya hydropower project, the Bagobo-Tagabawa and other residents of Sibulan and Tudaya look forward to an even better standard of living.

- Hydro Electric Development Corporation (HEDCOR) is registered with the Securities and Exchange Commission on May 11, 1978. The company is formed to operate and maintain the four National Power Corporation (NPC) – owned hydroelectric power plants in Mintal, Davao City
- Ernesto Aboitiz becomes the first president of HEDCOR

1987

EO 215 is signed by President Corazon Aquino.

- President Corazon Aquino on July 10, 1987, opening opportunities for the private sector to build and operate power-generating facilities and allowing the sale of power to the NPC and other customers. This sparks Hedcor to explore and determine the feasibility of developing run-of-river plants in Benguet, eventually leading to the construction of Irisan 3, Ampohaw and Sal-angan Hydroelectric Power plants located in Tuba, Sablan and Itogon, Benguet respectively.
- Jon Ramon Aboitiz is appointed president of HEDCOR after Ernesto Aboitiz joins the NPC.



-1990

HEDCOR starts construction of 3 plants in Benguet.

 In 1990, HEDCOR starts construction on the 1.2-MW Irisan Hydro 3, 4-MW Ampohaw Hydro, and the 2.4-MW Sal-angan Hydropower plants in Benguet.



1992

NMHC starts the construction of the Lonoy plant; 4 more plants are commissioned.

- NMHC begins construction of the Lonoy Hydroelectric Power Plant in Bakun, Benguet.
- Talomo Hydro 1 is commissioned on May 13, 1992.
- Bineng Hydro 2b is commissioned on August 6, 1992.
- Upper Takbo plant is commissioned on August 8, 1992.
- Lower Labay Hydro is commissioned on June 19, 1992.
- The Asin plants damaged by typhoon Trining are rehabilitated to resume operations at maximum capacity.

1978

1985

HEDCOR enters agreement with BWD to rehabilitate and operate the Baguio-owned Asin plants.

 HEDCOR signs a contract to rehabilitate and operate the four hydroelectric power plants owned by the City of Baguio. The contract states a sharing agreement between the City of Baguio, the Baguio Water District (BWD) and HEDCOR. Through the agreement, three plants in Asin, Tuba, and the Kennon Road Plant become fully operational in mid-1986. Improvement in the succeeding years has increased the plants' aggregate capacity from 700 KW to 3.6 MW.

1988

The first HEDCOR-built hydroelectric power plant in Benguet is constructed.

- In March 1988, HEDCOR builds the 500-kilowatt 745 for Philex Mining Corporation, the first Hedcorbuilt hydroelectric power plant in Benguet
- Romy Ronquillo is designated as the third president of HEDCOR, taking the helm from Jon Ramon Aboitiz.

1991

RA 7156 is passed; Northern Mini Hydro Corporation (NMHC) is formed; HEDCOR and NMHC start construction on 6 more plants in Benguet; 5 more plants are commissioned; Hydro Specialists, Inc. is formed.

- Republic Act No. 7156, known as the Mini Hydro Electric Power Bill, is passed giving incentives to private investors engaged in Mini Hydro development.
- Northern Mini Hydro Corporation (NMHC) is formed to construct the 4–MW Upper Takbo Hydro (now known as the FLS hydroelectric plant), and the 2–MW Lower Labay Hydroelectric Power Plant both located in Bakun, Benguet.
- Construction also begins on the 1.6-MW Bineng Hydro 1, 1.5-MW Bineng Hydro 2, 0.68-MW Bineng Hydro 2b, and the 3-MW Bineng Hydro 3.
- Irisan Hydro 3 is commissioned on June 15, 1991.
- Ampohaw Hydro is commissioned on August 26, 1991.
- Sal-angan Hydro is commissioned on October 6, 1991 and starts to deliver to Philex Mining Corporation through a 15-year Power Sales Agreement (PSA).
- Bineng Hydros 1 and 2 are commissioned on November 30 and December 4, 1991 respectively.
- Typhoon Trining severely damages the Irisan Hydro 3 and Baguio-Asin plants. The Kennon plant is completely destroyed and decommissioned after the typhoon renders it unsalvageable.
- Hydro Specialists, Inc. is formed as the design company and management arm of HEDCOR and NMHC.





1994

Three hydros are upgraded; Total Quality Management program is launched

- The 1.6 MW Bineng Hydro 1 is upgraded to 3.2 MW, likewise Bineng Hydro 3 is upgraded to 3.5 MW.
- Ampohaw Hydro is upgraded from 4 MW to 5.2 MW
- The Total Quality Management (TQM) program is launched putting emphasis on teamwork and efficiency. It enables the Hydro Group to continuously enhance performance through Quality Improvement Projects (QIPs).
- Erramon Aboitiz is appointed the new president of HEDCOR, the fourth to serve in such a capacity.





2000

HEDCOR is awarded its first ISO certification.

- ISO 9001:1994, the international standard for quality management, is awarded to HEDCOR in 2000 for the Ampohaw Hydropower plant, the first ISO certified mini hydropower plant in the country.
- Rene B. Ronquillo becomes the 5th President of HEDCOR.

2002

HEDCOR receives TESDA's Kabalikat Award

 TESDA confers HEDCOR the Kabalikat Award for exemplary contributions to the advancement of technical-vocational education and training in the country.

2002

1999

HEDCOR enters O&M business with the Bakun AC Hydro;

 HEDCOR marked its entry in the operations and maintenance (O&M) business with the management of the 70 MW Bakun AC hydropower plant in Alilem, Ilocos Sur in 1999.

1993

HEDCOR enters into a PSA with NPC; a new sharing agreement covering the Asin Plants is reached; Lon-oy Hydro is commissioned; Upper Takbo Hydro is upgraded to 5.9 MW

- HEDCOR and the NPC sign a Power Sales Agreement on January 20, 1993
- A new sharing agreement covering the Asin plants is reached among the City of Baguio, the BWD, the Benguet Electric Cooperative and HEDCOR.
- The 3.6 MW Lon-oy Hydropower plant is commissioned on July 24, 1993.
- Upper Takbo Hydro is upgraded from 4 MW to 5.9 MW in June of the same year.



1996

The Upper Takbo Plant is renamed Ferdinand L. Singit Hydroelectric Power Plant; three more hydropower plants are upgraded.

- The name of the Upper Takbo plant is changed to Ferdinand L. Singit (FLS) Hydro in memory of its Plant Engineer who passed away in 1995.
- Ampohaw is upgraded yet again, this time to a capacity of 8 MW
- Bineng Hydro 2 is re-commissioned on May 19, 1996 with an upgraded capacity of 1.8 MW
- Bineng Hydro 3's capacity is upgraded again to 4.5 MW and is recommissioned on June 3, 1996.

Ampohaw is re-commissioned

 Ampohaw Hydro, with a new capacity of 8 MW is re-commissioned on June 20, 1997.

2001

Electric Power Industry Reform Act is approved; FLS Hydro is re-commissioned. Asin Main Sub-station (AMS) is completed; Cleanergy is launched.

- In June 2001, the Electric Power Industry Reform Act (EPIRA) is approved, setting the stage for the deregulation of the domestic power industry.
- FLS Hydro is upgraded to produce 5.9 MW and is re-commissioned on August 15, 2001
- The construction of Asin grid's 69KV substation is completed to facilitate the Energy Power Supply Agreement (EPSA) between HEDCOR and San Fernando Light & Power Company. Delivery of power is done through the Open Access Transmission Services (OATS) which is a feature of the EPIRA.
- Cleanergy is launched to offer clean and renewable energy to help mitigate global warming; www. hedcor.com is also launched in the same year.



2004

HEDCOR wins bid for the Talomo Hydroelectric Power System;

- HEDCOR is declared by the Power Sector Assets and Liabilities Management Corporation (PSALM) as the winning bidder for the Talomo Hydroelectric Power System in March 2004 with a bid of \$1.37M. The Talomo power plants are formally turned over on January 26, 2005 and inaugurated in May of the same year.
- HEDCOR receives DOLE's Gawad Kaligtasan and Kalusugan Award in recognition of outstanding achievements of establishments in responding to the safety and health needs of workers, workplace and community.



2007

Hedcor Sibulan, Inc is formed; Construction starts for Sibulan Hydro Project.

- Hedcor Sibulan, Inc. (HSI) is formed
- The consortium involving Hedcor and Davao Light and Power Company (DLPC) signs a 12-year Power Supply Agreement (PSA) in March 2007. Under the PSA, the consortium will supply DLPC with 200 GWh of energy annually.
- The construction of the 42.5 MW Sibulan Hydro Project commences on June 25, 2007



2010

Sibulan Hydroelectric Power Plant is inaugurated; Irisan Hydro 1 begins construction:

- 42.5 MW Sibulan Hydropower Plants are launched and inaugurated by President Benigno Aquino III.
- Construction begins for the 3.8 MW Irisan 1 Hydropower Project
- In October 2010, Hedcor tops 53 institutions nationwide to bag the Labor Secretary's Institutional and Individual Awards, the highest honor bestowed upon an individual or institution for initiatives on Occupational Safety and Health (OSH).



2012

Irisan Hydro 1 begins commercial operations; Tudaya 1 and 2 Hydros start construction; Municipality of Sabangan enters agreement with Hedcor to build Hydropower Project.

- Irisan Hydro 1 begins commercial operations following the grant of a Certification of Compliance from the DOE on April 30, 2012.
- Construction gets underway for the Tudaya 1 and 2 Hydros with a combined capacity of 13.6 MW.
- Hedcor is all set to build the 13.2 MW Sabangan Hydropower project, its first hydropower project in the Mt. Province.

2003

2003

HEDCOR, HEU and NMHCEU sign collective bargaining agreements.

 HEDCOR and Northern Mini Hydro employees' unions HEU and NMHCEU sign their respective collective bargaining agreements (CBA) in 2003. The CBAs represent the company's commitment to their partners and most valuable assets: the team members.

2006

Hedcor, Inc. is formed; Asin Plants are turned-over to the City of Baguio.

- On May 27, 2005 HEDCOR and the NMHC are merged under the Benguet Hydro Corporation (BHC). BHC is then renamed Hedcor, Inc. due to its strong reputation and brand recognition in the industry, and among the local government units and the communities.
- A new logo is released representing the merger.
- The Asin plants are turned over to the City of Baguio in December 2006

2008

Sibulan Hydropower Project registers as a Clean Development Mechanism project; All Hydroelectric Power Plants become ISO-Certified;

- In May 2008, HSI obtains a P3.5B syndicated loan from a consortium of local banks.
- HSI is the first hydropower facility in the Philippines to be registered under the United Nation's Framework Convention on Climate Change (UNFCC) as a Clean Development Mechanism (CDM) project.
- Collective ISO certifications 9001:2000 and 14001:2004 are given to all plants in December 2008.
- Along with the renewal of the CBA, the two unions merge in 2008 to form the Hedcor Kabisig Council.

2011

Management of Bakun AC reverts to Hedcor; Irisan Hydro 1 is completed;

- AboitizPower assumes full ownership of the Bakun AC plant on March 30, 2011 after purchasing all the shares and interests of Pacific Hydro Ltd. of Australia. The management of Bakun AC as a run-of-river schemed plant, is returned to Hedcor as it was in 1999.
- Construction of the Irisan Hydro 1 is completed and formally turned over to the Operations team on November 2011.
- Hedcor bests other companies and receives the Outstanding Labor and Management Cooperation (LMC) Award for Industrial Peace during the LMC National Convention led by the National Conciliation and Mediation Board of the Department of Labor and Employment and the Philippine League of Labor–Management Cooperation Practitioners.
- The Department of Environment and Natural Resources cites Hedcor for its clean energy generation and watershed management initiatives. The company is honored with the Partner in Environment Award for its unwavering support of activities that protect and enhance the environment in the regions.



AEV, AboitizPower poised for further expansion

Coming on the heels of good performances in 2012, Aboitiz Equity Ventures, Inc. (AEV) and Aboitiz Power Corporation (AboitizPower) are well positioned for more growth, continuing to implement strategic initiatives for further expansion in the midst of the country's strong economy.

Erramon I. Aboitiz, (EIA) AEV and AboitizPower president & CEO, revealed growth plans and also reported on last year's results during separate annual stockholders' meetings and briefing on May 20 at the Radisson Blu Hotel in Cebu City and on May 23 at the InterContentinal Manila in Makati City.

The May 20 stockholders' meetings were the last to be held in Cebu City, as the new corporate headquarters of AEV and AboitizPower has been transferred to the Bonifacio Global City in Taguig.

The power business will remain at the forefront of this expansion with the building of new generating capacity to support the anticipated economic growth in the country.

"We envision that our growth will come from

new greenfield and brownfield projects that will be needed to supply the expected increase in demand brought about by strong economic activity," EIA said.

"AboitizPower will be investing about P125 billion to build new power plants over the next 5 years bringing our attributable capacity to roughly 3,500 megawatts (MW), 50% more than what we have today," he said.

For AEV's banking units, UnionBank's initiatives on strengthening its customer franchise will continue, Aboitiz said, giving priority to customer satisfaction through "enhanced retail focus, superior innovation and product customization, and stronger sales management approach." He added that UnionBank will also continue to focus on improving the performance of its earning assets portfolio, with loan asset acquisition in the retail, middle-market and corporate sectors.

As a newly acquired subsidiary of UnionBank, thrift bank City Savings Bank will continue with its focus to become the preferred Teachers' Bank in the Philippines, particularly expanding its customer franchise in Luzon and other civil servant market segments. UnionBank's strengths in technology, deposit generation and organizational capability is expected to optimize the potential of CitySavings' business model.

For AEV's wholly owned food subsidiary Pilmico Foods Corporation, EIA said initiatives in 2012 were aimed at "growing our core business while continuing to focus on optimizing our resources to remain being a low-cost producer." New mooring facilities and dredging work completed last year now allow Panamax vessels to dock at Pilmico's Iligan port, thus reducing freight rates. The company is also expanding its feed milling and swine-growing facilities.

Investment opportunities

EIA said that as part of AEV's efforts to augment earnings and the growth potential of its core businesses, "we are looking at other investment opportunities that we believe can be built into sizeable businesses," referring to the company's acquisition of Aboitiz Land, Inc. from Aboitiz & Co. last year.

AboitizLand has an inventory of existing and potential projects, as well as access to a land bank that will ensure the continuity of development projects. It also has strong recurring income from its industrial estates. In 2012, AboitizLand formed a consortium with Ayala and ADC & HAS Airports to bid for the Mactan International Airport terminal project, AEV's first public-private partnership (PPP) project.

AboitizLand will continue to roll out more residential projects and expand its industrial zone business. Last month, it further strengthened its partnership with Ayala Corporation by forming a 50–50 joint venture with Ayala Land, Inc. to acquire and develop land within Cebu province.

In support of its sustainability philosophy, AEV entered into a joint venture with UK company GazAsia Ltd. to build and operate plants to produce liquid bio-methane fuel from organic waste to replace oil used in transportation. An estimated investment of US\$150 million will be poured into building the plants over the next 5 years.

AEV's business development team is constantly scanning the markets looking for new business opportunities that are scalable and will generate strong recurring profits and cash flow.

"As we look to 2013 and the years ahead, what will differentiate us from our competitors is not just the soundness of our strategies, but the effectiveness and timeliness of our execution," EIA said.

2012 Results

AEV booked consolidated revenues of close to P81 billion in 2012, 13% higher than the previous year. Consolidated earnings before interest, taxes, depreciation and amortization



(EBITDA) reached P41 billion, up by 5%, largely due to the growth in operating profits of the company's power and banking units.

As such, AEV turned in a consolidated net income of P24 billion, translating to an earnings per share (EPS) of P4.33, 13% above 2011 levels. Return on equity for the year remained very healthy at 34%.

The power group provided the lion's share contributing P18.8 billion – up by 14% from the previous year – or equivalent to 78% of the total earnings contributions from AEV's operating businesses. The banking units turned in P3.9 billion or 16% of AEV's total income, while the food group contributed the balance of P1.3 billion.

AEV's balance sheet remains very strong; as of Dec. 2012, the company's total assets increased by 11% to almost P223 billion.

For its part, AboitizPower ended 2012 with consolidated revenues of close to P62 billion, 14% higher than in 2011. The increase was mainly driven by improvements in the topline performance of both the generation and distribution segments.

EBITDA increased by just 4% versus the previous year, amounting to P34.2 billion. But the company closed the year 2012 with a net income of P24.4 billion, 13% higher than 2011. This translated to an EPS of P3.32, versus P2.94 in the previous year. Return on equity remained very healthy and stood at 43% for the year.

The power generation business accounted for 89% of the total earnings from AboitizPower's business segments, contributing P22.8 billion to the company's income.

As of Dec. 2012, the total assets of AboitizPower increased by 6% to P163 billion.

TMO completes rehab of 242-MW Navotas barges

Therma Mobile, Inc. (TMO), a power generation subsidiary of AboitizPower Corporation, completed on time the rehabilitation of its four power barges in Navotas City which are now ready to supply power to the nearby CAMANAVA (Caloocan, Malabon, Navotas, Valenzuela) areas.

TMO had previously acquired the four bargemounted power plants from Duracom Mobile Power Corporation and East Asia Diesel Power Corporation last May 27, 2011. The barges, located at the Navotas Fish Port Complex and with a total generating capacity of 242 megawatts, have since then been undergoing repair to allow them to operate at full capacity by May 2013.

Prior to their acquisition by TMO, the bunker C-fired diesel plants—designed for peak load application—have been idle for five years.

"I came several times as the rehabilitation and renewal work was progressing and was literally amazed at how it was possible to get each and every component to work again as one unit," Antonio R. Moraza, AboitizPower executive vice president and Power Generation Group chief operating officer, said of the barges' speedy

The national wealth tax is 1% of the company's gross revenue from the previous year and is distributed among the local governments of the province, municipality, and barangay. Additionally 20% goes to the province, 45% to the municipality, and 35% to the barangays. Since 2009, SNAP has remitted a total of P103,024,842.58 in national wealth taxes to their host communities in the province of Benquet.

In his speech, Fongwan stressed the need to utilize the fund for underdeveloped areas "without electricity, areas we need to give more livelihood" as well as areas "where we need to give more attention to environmental projects, and [address the] basic needs [of the] barangays and municipalities."

Blomdahl delivered a message on behalf of SNAP-Benguet President and Chief Executive Officer Emmanuel Rubio, saying that it is "through contributions such as the national wealth tax that we can help spur growth in our communities."

Hedcor intends to build two cascading plants that will harness power from the Amusig, Guihean, and Tanaon rivers. The Manolo Fortich Hydro 1 will have a capacity of 35.2 megawatts (MW) and the Manolo Fortich Hydro 2 will generate 16.4 MW. Both plants combined can produce a total of almost 300 million kilowatthours a year.

Other parties to the MOA signing were community leaders from barangays Guilang-guilang, Santiago, Dalirig, and Maluco.

Negros Oriental provincial board okays Hedcor hydro project

The Negros Oriental Provincial Board passed a resolution on March 5 endorsing the 22–megawatt hydroelectric power project of Hedcor, Inc. The hydro plant will be built in Barangay Kauswagan in the municipality of Mabinay and Barangay New Namangka in the town of Manjuyod.

Hedcor officials appeared before the Board and gave a presentation about the project. Also present in the session are representatives from the National Irrigation Authority, Department of Energy, and Department of Environment and Natural Resources who raised no objection to the project.

In November last year, in separate sessions, the barangays of Kauswagan and New Namanka and the municipal councils of Mabinay and Manjuyod endorsed the project.

The province's local government units expect to reap economic and social benefits from the project. Hedcor vouched for inclusive growth

of the communities with the project. These benefits will be in black and white through memoranda of agreement.

The endorsements will pave the way for the company to apply for the necessary permits in constructing the hydropower project.

The hydropower project, the first hydro project of Hedcor in Visayas, will tap the llog River river and will generate 84 million kilowatt hours annually. It will be an addition to the 19 plants in Ilocos Sur, Davao and Benguet that Hedcor currently operates.

Hedcor, Davao Light recognized at KAPATID Awards

Aboitiz-owned power firms Hedcor, Inc. and Davao Light & Power Co., Inc. (Davao Light) were among the 11 finalists at the sector-wide Kapatiran sa Industriya (KAPATID) Awards held last May 24 at the Marriott Hotel Manila.

In addition to being an Awards finalist, Hedcor also bagged a special citation for Industrial Peace and Harmony—the second consecutive time it won a KAPATID award—for its implementation of programs that facilitated enterprise–level cooperation leading to better labor relations.

Effective labor relationships contributed greatly to advancing negotiations between the management and the company union. Hedcor's last negotiation in 2011 was sealed in a record seven hours, and is up for renegotiation this year, the power firm's 35th anniversary (see cover story).

The KAPATID Awards, launched in 1995,

is a comprehensive search for outstanding workplace policies and programs held every two years by the Employees Confederation of the Philippines. The Awards also recognize enterprises with sound and harmonious management and worker relationships.

Hedcor, a unit of Aboitiz Power Corporation, is the country's run-of-river hydro power plant developer, with a current portfolio of 19 plants in Luzon and Mindanao.

MEZ, BEZ beef up substation protection system

Kaibigan innovation helps save VECO millions

Visayan Electric Co., Inc. (VECO) recently recognized technician Niceporo Salvaleon, Jr. and meter engineer Alvin Basubas for building a power meter tester which would have otherwise cost the company millions. Salvaleon and Basubas of VECO's Power Metering Department (PMD) were tasked to check instrument-rated (CT-rated) meters typically used by large consumers. They check the meters to see whether these are still working properly and to quard against pilferage. Job exigencies pushed them to improvise and build the devise from off-the-shelf parts. Replacement parts and accessories for the imported devise were expensive and took several months to order. Due to the high cost of the instrument, there were just a few units being shared among AboitizPower distribution utilities. "I never had any intention of making such as device. But when we went with Revenue Protection Department (RPD) to test some meters, I realized the difficulty in doing the job because

of the lack of equipment for inspection. We only have a few meter testers because it is very expensive, "Salvaleon said.

Salvaleon thought of turning a digital power meter into a tester and using it with Basubas's invention. A co-worker programmed the display to show the results. They found that these results

were consistent with that of the imported equipment. Basubas invented the duckbill, an instrument used to determine the accuracy of any meter in the field. He used popsicle sticks and alligator clips with the equipment. He improved the idea by cutting a printed circuit board into a popsicle. VECO now has 10 Niceport (derived from Salvaleon's name) testers. This saved VECO 99% of the cost of buying a brand new

imported device. Salvaleon is now on his 17th year in VECO. He is still motivated to work every day. He advises his colleagues to work hard, not only to accomplish a task but to impart passion at work. "Love your job," he quipped. "Whatever knowledge they acquire, they should use this at work. If they want to grow, it would be good to show what they can do," said Basubas, who has been with VECO for 14 years.

are also provided with guidance and counseling, recreational activities, and spiritual and moral formation. These are done to prepare them for integration in the formal education at the appropriate school level.

A marketplace to boost the incomes of families raising aquatic animals for food is set to break ground in Cebu City, thanks to a group of Aboitiz Foundation, Inc.-scholars that spearheaded a citywide environmental project there.

Foundation scholars Sandra Jane Soon, Ronald Gonesto, Winde Bontilao, Raymart Abellanosa, and Johanna Fretz Bayking said they will establish an aquaponics micro-market in Barangay Agsungot, Cebu City as part of their community-based environmental project "LUAP LAB: LiveGreen Urban Agriculture Project Lihok Alang sa Barangay,"

"This project (LUAP LAB) is implemented to provide extra income to households through the establishment of [a] barangay micro-market where the households' surplus harvest [will be] marketed and sold," said Soon, the group team leader.

LUAP LAB is an Aboitiz Foundation project that aims to educate communities on the benefits of urban agriculture as an immediate source of food, as well as promote proper waste management practices via various training and capability-building seminars.

The project was a brainchild of the scholars'

group, and was one of the three winning proposals the 1st Aboitiz Scholars' CSR (Corporate Social Responsibility) Summit 2011.

Notably the planned aquaponics micro-market follows the group awarding Sitio Lintuang in Barangay Agsungot with a "Pro-Active Purok Award" consisting of a plaque and Php10,000 cash for the sitio's adherence to "urban agriculture" and environmentally-friendly practices last

February 18.

Sitio Luntang, headed by President Ramil Sundo, edged out the barangay's other sitios, namely Sitios Agbuakan 1, Agbuakan 2 and Upper Agsungot, who also received plaques and cash for their environmental efforts.

Last year, Aboitiz Foundation allotted P 200,000 for LUAP LAB, according to the Foundation's 2012 annual report.

Hedcor starts work on new hydro plant; project to benefit Sabangan community

Hedcor, Inc. has broken ground for its Sabangan hydroelectric power project in Mt. Province.

As host to Hedcor's newest plant, Mt. Province and Sabangan town stand to receive a host of economic benefits, including at least P15 million in government and real property taxes as well as community shares. The company will also bring to the community its CSR programs.

Members of the Tinmakudo ancestral domain and the hosting barangays will also have shares in the power plant's generation output. This is on top of other financial benefits that the community will receive under the government–mandated Energy Regulation 1–94, which they can use to fund electrification, development, and livelihood,

and reforestation, watershed management, health and environmental enhancement projects.

Local landowners also stand to benefit from rentals for the project's use of portions of their properties.

The Sabangan hydroelectric power project will have a 14-MW capacity and will be located in Barangays Namatec and Napua; the plant will harness power from the Chico River. Construction is set to be completed in 22 months.

Mt. Province Gov. Leonard Mayaen has also endorsed the project, citing the benefits that the company would bring to the host barangays, the municipality and the province.

Multisectoral environmental group to oversee Sabangan project

The multipartite monitoring team (MMT) went through a 3-day capability building workshop geared towards preparing each team member to conduct environmental monitoring during the construction period.

"The monitoring of the project is a shared responsibility between Hedcor and the local government," stressed DENR-EMB CAR Director and MMT member Oscar Cabanayan.

Monitoring will commence when construction starts and will continue until completion of the

project. The project is slated to break ground as soon as its Special Land Use Permit is released. Construction is expected to take around two years to complete.

The Sabangan Hydroelectric Power project is a run-of-river hydropower scheme that will harness the Chico River is current to generate over 55 million kilowatt-hours of clean and renewable energy annually.

Iligan students get free bread, new classrooms from Pilmico

Pilmico Foods Corporation, the food manufacturing arm of the Aboitiz Group, donated bread snacks and classrooms to students in Iligan City as part of its commitment to help improve students' educational performance in the city.

In June, Pilmico kicked off its Kutitap Feeding Program, sharing various chocolate, corn, cheese, Spanish, pineapple, and buko breads with 2,436 students at Echavez Elementary School, Bagong Silang Elementary School, Cabili Village Elementary School, and Tomas Cabili National High School–Sta. Elena Annex.

The Kutitap Feeding Program—which supports an Aboitiz Foundation, Inc. CSR pillar, Primary Health and Child Care—consists of the distribution of nutritious and energy–rich Pilmico breads during the snack times of kindergarten and Grade 1 students, thrice weekly for 45 weeks.

This activity promotes education and envisions alleviating short-term hunger minimizing malnutrition, boosting school enrolment and participation, reducing absenteeism and improving academic performance.

Moreover, the feeding program also unites communities in the common purpose of providing meals for children with Pilmico partnering with local bakeries and dealers Frosty Bites, Shandy's Bakeshop and Cherrybelle's Bakeshop, which bake the distributed breads and in the process are also able to grow their respective businesses.

Meanwhile, In a bid to broaden its bread distribution, Pilmico last July 1 tapped Leyson Bakeship and D'Bauin Bakery to distribute more breads to additional beneficiary schools: Northeast II-A Central School, Kiwalan Elementary School, Northeast 1A Central School,

Luinab Elementary School.

In addition, Pilmico opened last June 5 Buildings 1 and 2 of the Sta. Elena school project for the use of public kindergarten and high school students inside the Bayanihan ng Bayan sa Iligan Village in Barangay Sta. Elena, Iligan City, also as part of the company's CSR efforts.

A typical Sta. Elena school building is four storeys high and contains six classrooms.

The four-building Sta. Elena school project, considered Pilmico's single biggest corporate social responsibility initiative at P25.09 million, was initiated after Typhoon Sendong in late 2011 damaged several schools in the area, forcing students to travel far to study in crowded classrooms.

Today, classrooms at the Sta. Elena school project already have built-in blackboards, chairs, restrooms, and other furnishings.

WeatherPhilippines on track with device rollout

WeatherPhilippines Foundation, Inc. (WPF), is nearly halfway done with its goal of installing roughly 1,000 automated weather stations (AWS) by end–2013, with more AWS trainings set to take place moving forward.

A total of 495 AWS have already been installed across the Philippines as of end–June, according to Celso Caballero III, WPF general manager.

Through its partnerships with the League

of Cities in the Philippines (LCP) and League of Provinces of in the Philippines (LPP), WPF—the Aboitiz Group's largest corporate social responsibility effort to date—has gained much local government support and it is now poised to orient more stakeholders on the AWS.

"WPF is conducting a series of training sessions for disaster risk officers, public information officers, and administrators of either the provinces or the cities where the AWS are located, specifically those in partnerships with LPP and LCP," Caballero said.

WPF's training will detail the features of WPF's web portal and enable users to find information on localized weather or severe weather such as typhoons. Users will also find other useful information like basic meteorological or weather articles and see actual atmospheric/meteorological readings—such as solar radiation, wind speed and direction, precipitation, temperature, pressure, and humidity—in their locale.


Previous WPF training sessions were conducted last April in Davao, Butuan City, Tangub City, Tagbilaran, Bacolod, Legazpi City, La Union, Cebu, Iloilo, Quezon City, Cagayan de Oro City, and Baguio City.

In the future, WPF aims to add training in basic weather and climatology, which includes atmospheric and earth sciences, as well as support on local disaster risk resilience.

"WPF's localized weather information focuses on helping Filipinos living in high-risk areas in the country and those vulnerable to climate-related disasters. It is also aimed at helping local government units by providing supplemental information to keep track of localized weather information in order to make informed decisions in times of calamities," Caballero added.

WPF, founded by a partnership between Aboitiz Foundation, Inc., Union Bank of the Philippines, and Swiss firm Meteomedia, aims to deliver critical and accurate localized weather forecasts to the Filipino community, with the hope of improving nationwide disaster preparedness and timely response to variable weather conditions.

WPF uses AWS that are solar-powered and self-sufficient, with the capability to measure various indicators for accurate, localized weather information. Data from the weather instruments are sent to Meteomedia servers to be interpreted by meteorologists and posted on www.weather.com.ph.



CIPDI volunteers plant 20k mangroves on World Wetlands Day



Cebu Industrial Park Developers, Inc. (CIPDI) brought 785 volunteers together for its World Wetlands Day observance this year, six times more than its volunteer count last year, to plant 20,000 mangrove propagules at its West Cebu Industrial Park (WCIP) mangrove area in Sitio Langob, Barangay Nangka, Balamban.

This year, 365 students from the different elementary and high schools in Balamban joined the activity. Nangka National High School Principal Susan Tribunalo said the activity helped increase students' awareness on the importance of mangroves.

Hedcor spearheads cleanup of Benguet rivers

Hedcor, Inc. recently initiated river cleanup drives, cleaning two tons of wet waste from its adopted rivers around Tuba and La Trinidad in Benguet.

The series of cleanup drives is an annual initiative of Hedcor in support of the World Water Day last March 22, and the Earth Day last April 22. Earth Day and World Water Day are two international movements that aim to strengthen awareness on environmental preservation.

Over 100 Hedcor team members accompanied by the local community and government units collected waste around the rivers' tributaries. The group collected up over 700 kilograms (kg) of waste from the Bolo creek in La Trinidad and 900 kgs from the Elew Creek in Irisan.

The Elew and Bolo creeks are tributaries of the Elew and Balili rivers both of which are under Hedcor's care through the Department of Environment and Natural Resources' Adoptan–Estero program. The two rivers feed seven of the company's 11 power plants in Benguet generating close to 80 million kilowatt–hours of clean and renewable energy from run–of–river hydropower annually.

SNAP provides 'green' charcoal training for Benguet communities

SN Aboitiz Power-Benguet, Inc. (SNAP-Benguet) continues to provide potential livelihood and added income opportunities for its employees and community members through a series of training seminars. It recently sponsored a two-day training on the production of environmental charcoal briquettes using agrowaste materials attended by 27 participants, composed of current and former employees, and community members.

Charcoal briquettes—powdered charcoal residue mixed with a binder—are produced using a simple technology that has minimal environmental impact. Trainees were taught the drum method of producing charcoal out of agro-forest waste such as dried leaves (including pine needles), twigs or branches that have fallen from trees. Compared to the traditionally produced charcoal, environmental charcoal briquettes are smokeless, burn longer, and are more cost effective.

The process requires the fabrication of a carbonizing drum, grinder, and mixer and molder for compacting. SNAP-Benguet produced all the machinery on site for the use of the participants. Logistics, including food and Personal Protective Equipment, were also provided by the company.

The training is part of the expansion of the Material Recovery Facility (MRF) project, which is geared towards environmental consciousness and additional prospects for livelihood and employment. As a business venture, the market for environmental briquettes is open since Department of Environment and Natural Resources has strictly stopped the market of traditional charcoal. The demand for environmental charcoal briquettes is high in both rural and urban areas where charcoal is a

necessity.

There are also plans to conduct other trainings such as composting and organic farming, for joint implementation with the Benguet Provincial Agriculture office. In order to maximize the potential business aspect of these trainings, the company is coordinating with the Department of Trade and Industry for trainings on Small Scale Entrepreneurship, which will include packaging, marketing, and networking.

SNAP-Magat wins mother nature award


The Aboitiz Group upheld its commitment to initiatives to save Mother Earth by taking part in the annual Earth Hour celebration held on March 23 this year.
