



# The Aboitiz Foundation: a 25-year legacy of helping people help themselves

Aboitiz Foundation, Inc., the CSR arm of the Aboitiz Group, celebrates this year its 25th anniversary, marking a quarter century of caring for our less fortunate fellow Filipinos, and of being a neighbor of choice in various locations nationwide.

Established in 1988, the Aboitiz Foundation has since been a proponent of education, enterprise development, and environmental sustainability in the country.

"Each of our social development initiatives articulates our legacy of helping people help themselves," said Aboitiz Foundation President Jon Ramon Aboitiz (JRA). He noted that education remains its biggest thrust among its focus areas.

"We believe education should be a great leveler of society and that all our students should be given the chance to succeed in school. In essence, we as adults are called to be positive influences on the lives of our children and the Aboitiz Foundation takes ownership of this duty," JRA added.

Over the years, the Aboitiz Foundation has remained true to its commitment, nurturing a philosophy that dates back to the 1800s when the company's founders began donating to various groups and communities where Aboitiz companies operate.

In education, the Aboitiz Foundation supports programs aimed at strengthening the country's public education system, and transforming students into lifelong learners equipped with skills and knowledge that will prepare them for future challenges.

Alongside education, the Aboitiz Foundation

also engages in enterprise development by empowering communities through various forms of income-generating initiatives and livelihood programs.

In 2003, the Aboitiz Foundation added the environment as a major program component to strategically address the Group's green initiatives. Since then, this program has evolved to include sustainability initiatives that create a balance of people, planet and profit. Today, the Aboitiz Group is guided by five sustainability pillars: Rejuvenate Nature, Re-use/Recycle, Reduce, Renewable Energy, and Recharge Communities.

Meanwhile, amid increasing focus on climate change and disaster preparedness, Aboitiz Foundation also supported WeatherPhilippines Foundation, Inc. (WPF), a partnership between the Aboitiz Foundation, Union Bank of the Philippines, and Swiss weather services group Meteomedia. WPF, which seeks to install roughly 1,000 automated weather instruments across the country by end–2013, is the Aboitiz Foundation's largest CSR effort to date.

Over the years, the Aboitiz Foundation's endeavors have produced tangible, meaningful results. To date the Foundation has donated 597 classrooms, 1,589 computers, and over 100 library kits; built 14 cooperative training centers; disbursed 381 microfinance loans; and planted 2.68 million seedlings.

But this is just a start. As the Aboitiz Foundation enters its next 25 years of existence, it shall continue to strive to uplift the lives of Filipinos through a genuine passion to serve, and by doing so, help people help themselves.

# Aboitiz Foundation turns over 40 classrooms to AGAPP, pledges 40 more in 2014

As part of its 25th anniversary celebration, Aboitiz Foundation, Inc. turned over 40 kindergarten classrooms last month to its partner, the Aklat, Gabay, at Aruga Tungo sa Pag-angat at Pag-asa Foundation (AGAPP), a non-profit organization geared toward preschool building construction, among others.

The turnover ceremony took place last August 14 at the Blue Leaf Events Pavilion in McKinley Hill, Taguig and was attended by several Aboitiz Foundation beneficiaries together with AGAPP Chairperson Pinky Aquino-Abellada and Education Secretary Bro. Armin Luistro, FSC.

The donation of 40 classrooms completed Aboitiz Foundation's goal of providing 134 classrooms to AGAPP by 2013, demonstrating how education is an integral component of the Aboitiz Group's corporate social responsibility (CSR) initiatives.

"We believe education should be a great

equalizer in society, and that all our students should be given the chance to succeed in school. In essence, we as adults are called to be positive influences on the lives of our children, and the Aboitiz Foundation takes ownership of this duty with its commitment to public school education," Jon Ramon Aboitiz (JRA), Aboitiz Foundation President, said.

Included in this turnover were two classrooms donated care of Pilmico Foods Corporation to Iligan City North 1 Central School in Tibanga, Iligan City last August 6 and two more classrooms donated to San Vicente Elementary School in Sto. Tomas, Batangas through AP Renewables, Inc. (APRI).

"Our hearts and minds have always been with our children. Hence, our focus on education, as we believe that education is the most important intervention in social development," said Sabin Aboitiz, Pilmico President and Chief Operating Officer.

For his part, APRI President and Chief Operating Officer Michael Pierce said the partnership with AGAPP shows the Aboitiz Group's commitment to support government efforts to improve the quality of public education in the country.

"The completion of the San Vicente Elementary School classroom represents the Aboitiz Foundation's continuing support and passion to improve delivery of primary education for communities in need." Michael Pierce, APRI President and Chief Operating Officer, for his part, said.

Meanwhile, JRA announced that the Aboitiz Foundation Board of Trustees already approved an additional pledge of 40 more AGAPP classrooms for 2014, sustaining the Foundation's strong commitment to education moving forward.

The Aboitiz Foundation turned over 52 classrooms in 2011 and then followed up with a donation of 42 more in 2012.

Part of the 2014 classroom donation is expected to come from Cotabato Light & Power Co., which signed a memorandum of agreement with the Department of Education to build two AGAPP classrooms last May 20 to build two AGAPP classrooms for Notre Dame Village Elementary School in Cotabato City.

The Aboitiz Foundation first partnered with AGAPP in 2011 for the latter's Silid Pangarap Project. Since then, the Aboitiz Foundation has been involved in developing child- and schoolfocused projects that benefit underprivileged children, building special classrooms for young children entering school for the first time.

CSR in the Aboitiz Group can be traced back to the company's modest beginnings in the hemp trade in the late 1800s. Today, the Aboitiz Group utilizes its resources to implement projects that uplift the lives of communities it serves.

In education alone, the Aboitiz Foundation builds school buildings, rewires classrooms, refurbishes science and computer laboratories, provides scholarships and financial assistance, donates computers and library kits, among others. with Donjie Vertuoso

Officer, announced last July—took effect last September 1.

Joining SMA at Aseagas are Juan "Ping" Alfonso (Chief Operating Officer), Ebbie Mabatid (Finance), Maribeth Marasigan (Brand, Marketing, Information Technology, Business Process), and Geraldine Polanco (Manpower and Administrative Support).

In May last year, AEV signed a joint venture agreement with GazAsia forming ASEAGAS. ASEAGAS' core objective is to provide sustainable and green transport solutions by producing LBM and utilizing waste that would otherwise be discarded in the process. While this is already implemented in many countries in Europe, this is new to the Philippines.

"We are indeed very excited for ASEAGAS in pioneering this new technology, as this project truly supports the Aboitiz Group's sustainability efforts, and will be used for the greater good of generations to come," EIA said.

A strategic opportunity presents itself in LBM, which is a low-emission, diesel fuel alternative targeted towards heavy-goods vehicles such as trucks and buses. LBM will help reduce air pollution, especially since vehicle emissions are a leading contributor to poor air quality in the Philippines and Asia.

To generate LBM as alternative vehicle fuel, ASEAGAS will need tons and tons of garbage and waste materials, which will then provide municipal waste management solutions to our prevalent garbage disposal problem, especially in urban areas. The ASEAGAS team is now focused on finding sources of waste materials such as landfills that will help generate LBM.



# Prudent borrowing, investment grade help Aboitiz ride out H1 market drop

Aboitiz Equity Ventures, Inc. (AEV) and its business units remain in the pink of financial health despite the stock market plunge in the first semester, thanks to ample market liquidity and the conglomerate's efficient debt management.

"Over the past two-and-a-half years, unlike other companies that have been building [up] their war chests, AboitizPower (Aboitiz Power Corporation) has paid off all its loans. We are very prudent; AboitizPower in fact is zero-debt at this point," Gabriel T. Mañalac, AEV Group Treasurer, said last June 26 at the The Asset-FINEX CFO (Chief Financial Officer) and Treasurers' Roundtable at The InterContinental Manila.

Mañalac was part of the program's Evolving Financial Markets panel which discussed challenges to capital-raising in the country and how CFOs and treasurers are responding to these.

Much concern was placed on the performance

of the Philippine Stock Exchange index (PSEi). Just before the roundtable (June 25), the PSEi erased all its gains for 2013 when it closed at 5,789.06 versus 5,812.73 on the last trading day of 2012.

Mañalac, however, assured the audience that AEV was unaffected by the market slump:

"There is enough peso liquidity in the market," he said when asked if the equity market's sour performance could affect AEV's borrowing plans. Mañalac also cited the investment grade the country received from Standard & Poor's as a positive factor for expanding companies like AEV and AboitizPower.

### Synergies highlighted, strengthened at Joint Audit & Risk Forum

The Internal Audit and Risk Management teams of Aboitiz Equity Ventures Inc. (AEV) are taking a leap forward in strengthening risk maturity for the company as the Joint Internal Audit and Risk Management Forum was held last July 16 at the Manila Polo Club.

"Because not all risks are easily auditable nor do they have just one owner, working together allows potential risks to be more effectively defined, uncovered, assessed for interrelationships, and managed to meet stakeholder expectations," Erramon I. Aboitiz (EIA), AEV President and Chief Executive Officer, explained.

To effectively fuse the rigorous planning and execution processes between audit and risk AEV Chief Reputation and Risk Officer Susan Valdez stressed the importance of communication in every step in mitigating business risks.

"Building a culture of measuring and managing risk means that risk management is clearly communicated and understood by every team leader and member across the organization, so that we all make the right decision every day that could mitigate any risk," she said in her presentation.

For her part, Marie Y. Tanate, AEV Assistant Vice President for Audit, said her main goal is to build a world-class internal audit team, which should have five essential elements:

- 1. A Quality Assurance Improvement Program
- 2. Maximized internal capabilities and resources through Combined Assurance
- 3. A high ratio of skilled and internationally certified auditors
- 4. A continuous, comprehensive approach to auditing that leverages technology
- 5. Being the source of internal talents for the business units

Enrique M. Aboitiz, Jr. (EMAJ), AEV Senior Vice President, noted the improvements made in risk over the years.

"A dozen years ago we did not have the foresight to develop our ERM (enterprise risk management). Since then we have taken our

Topics discussed during the two-day event included Overview on Losses; Loss Experience and Mitigation; Fundamentals of Transformers, Generators, Relaying, Battery; Testing and

Inspections. It also served as a refresher course also for the engineers.

The most significant discussions were on:

- 1. Damages and losses experienced globally in the power generation industry
- 2. Recognizing loss exposures for the particular generating sectors (geothermal, hydroelectric, coal and oil)
- Gaining first-hand knowledge of the extensive causal analyses that are conducted for power generating asset failures
- 4. The industry's efforts to learn from these experiences to determine the most effective mitigation measures to eliminate or reduce the financial exposures resulting from such losses.

### AboitizPower shares right-mix strategy at Mindanao Business Conference

AboitizPower First Vice President for Mindanao Affairs Manuel "Bobby" M. Orig was featured speaker at the 22nd Mindanao Business Conference (MinBizCon) held last August in Lanang, Davao City.

In his presentation, Orig shared AboitizPower's strategy in contributing to the security of electricity supply in Mindanao and the entire country. He said that in order to attain energy sufficiency, there must be an effective mix between renewable and non-renewable sources of power.

"The AboitizPower strategy has always been to pursue renewable energy sources as long as it is viable and power sources as long as their impact on rates can be justified," Orig told the plenary at the SMX Convention Center.

"(But) since the amount of power that can be produced from renewable energy is limited, we are also building power plants from nonrenewable power sources like coal and diesel/ bunker to make a meaningful contribution in meeting the country's energy needs and to help avert brownouts."

Orig reaffirmed AboitizPower's commitment to the growth of Mindanao with its P35-billion investment to add 365 MW to the Mindanao grid by 2015. To top it off, an additional P190-billion investment over the next five years is expected to bring the company's total nationwide attributable generation capacity to 3,422 MW, a 50% increase from where it is today.

The right-mix strategy is very visible in Mindanao where AboitizPower subsidiary Hedcor pursues its run-of-river hydro technology together with oil-based peaking plant of Therma Marine and the construction of the 300-MW Therma South clean coal power plant.

The MinBizCon is an annual gathering of senior business leaders and policy makers who exchange ideas on improving the business climate and competitiveness in Mindanao. President Bengino S. Aquino III opened this year's conference, which was held from August 8 to 10 under the main theme of preparing the region for the 2015 ASEAN Business Integration.

### **VECO starts Naga City electrification project**

Visayan Electric Co., Inc., the country's second largest power distributor, further broadened its operating network as it recently launched an electrification project in Naga City, Cebu with a ceremonial switch-on at the Naga City Gymnasium Complex.

The project was funded by East Asia Utilities Corporation and Cebu Private Power Corporation—joint ventures between Aboitiz Power Corporation (AboitizPower) with Vivant Corporation and El Paso Philippine Energy Co., Inc., respectively—under Energy Regulations 1–94, a government rule requiring power generators to provide financial benefits to host communities. The electrification projects may be initiated by the generating company as the fund source or the distribution utility as the project implementer.

"We are honored to provide support through this rural electrification project that is funded by AboitizPower and executed by VECO. Ultimately, this is the result of a shared vision of improving the quality of life of our host communities," Danel Aboitiz, AboitizPower Assistant Vice President for Special Projects and Business Systems Management, said.

VECO, as the franchised distribution utility,

initiated the implementation of this project, which is an extension of the distribution lines of VECO to the un-electrified areas in Naga City. The Department of Energy approved the project and allowed VECO to proceed with the electrification expansion affecting 22 sitios and 410 households.

Barangay Patag councilor Calixto Patag

expressed his excitement over the project saying, "Duna na gyud kami suga! Sa una, magto-on ang mga bata sa kangit-ngit. Karon, salamat sa VECO, ang atong kabataan makato-on na gyud pag-ayo." (Finally, we now have electricity! Before, our children studied in darkness, now, thanks to VECO, our children can study better).

### **BEZ upgrades Arpili substation feeders**

Balamban EnerZone Corporation (BEZ) completed the upgrade of its Arpili substation feeders 1 and 2 last April 21, boosting its operating network in Cebu.

Eleven substation feeders—which transfer power from a transmission system to an area's distribution system via overhead lines—were rehabilitated using standard Aboitiz Power Corporation pole constructions. Pin insulators were uprated from 15 kilovolts (kV) to 23 kV,

with long shank steel pins aimed at minimizing "nuisance tripping" brought by insects and geckos.

In addition, BEZ energized newly installed 800-meter distribution lines tapped into feeder 2 passing through Spine Road connecting Barangays Arpili and Buanoy within West Cebu Industrial Park 1 (WCIP 1). The project added to the flexibility of the BEZ power distribution system.

Because of the anticipated expansion of WCIP 2 this year, BEZ also upgraded its existing Arpili substation feeder 2 distribution line set–up into a double circuit, with feeder 1 aimed to supply power at the proposed WCIP 2.

The feeders upgrade was completed through BEZ and Mactan EnerZone Corporation with the help of Cebu III Electric Cooperative personnel. CERILI, a VECO accredited contractor, assisted in the project.

### Cotabato Light introduces new payment partners, SMS information service

In line with efforts to innovate and improve the company's customer service levels, Cotabato Light & Power Co. has broadened the number of its electric bill payment options and unveiled a text messaging information facility for customers.

Cotabato Light recently introduced three Third Party Collection Agents (TPCAs) as the company's accredited partners in the acceptance of electric bill payments. The authorized TPCAs are CIS Bayad Center, Inc., PJ Lhuillier Group of Companies (Cebuana Lhuillier), and USSC Western Union.

These TPCAs have about a total of 21 payments centers located within Cotabato Light's franchise area, and more than 3,800 branches nationwide. Now, Cotabato Light customers have more options in paying their electric bills.

With ASKCLPC, Cotabato Light hopes to provide more convenience to customers by saving them time and money instead of visiting or calling Cotabato Light offices for bill inquiries. This service facility also offers more options for the customers to know their electric bills on demand—anytime they want to. This digital billing information is also useful for customers upon paying at any of Cotabato Light's payment collections channels.

# Rehabilitated Binga hydroelectric power plant gets go signal from ERC

SN Aboitiz Power Benguet (SNAP-Benguet) received its Certificate of Compliance (COC) from the Energy Regulatory Commission (ERC) last September 2, marking a 25-megawatt increase in renewable energy supplied to Luzon.

Located in Brgy. Tinongdan, Itogon, Benguet, all four units of the Binga Hydroelectric Power Plant (HEPP) have increased its combined capacity from 100 MW in 2008 to 125 MW in 2013, following refurbishment that began in 2011.

The project required a new intake at higher elevation, new headrace, replacement and modernization of plant control system and replacement of electro-mechanical components. Construction and civil works started earlier in 2010.

"This certificate marks Binga HEPP's increased

capacity from 100 to 125 MW. But as a result of more efficient turbine technology, the plant is actually capable of producing up to 132 MW," said Emmanuel Rubio, SNAP-Benguet President and CEO. "Aside from providing a significant amount of clean and renewable energy to communities, this also means that we will be able to contribute to energy security by adding additional power generation capacity to the grid."

The certificate, which has a five-year validity, signifies that SNAP-Benguet has complied with the technical, financial, and environmental requirements prescribed in the Revised Rules for the Issuance of COCs for Generation Companies/Facilities. The original Binga plant, built in 1960, is among the oldest power facilities in the country. It is the

second plant SNAP-Benguet has rehabilitated, after Ambuklao HEPP, and modernized at state-of-the-art levels under its thrust of "operational excellence".

# Hedcor supports electric coop to light remote barangays

HedcorSibulan, Inc. of AboitizPower partnered with Davao del Sur Electric Cooperative (DASURECO) to provide electrification project to remote barangays in Davao del Sur. A Memorandum of Agreement was signed last June 24 to continue its project.

"Our commitment to provide electrification to our host communities will continue through the help of our partners like DASURECO", vice president for Mindanao Operations Rolando Pacquiao said.

The project started in 2011 where Hedcor provided DASURECO with a total of P6 million to implement the project. Two million pesos were turned over as cash to DASURECO for its own initiative electrification project while the remaining amount was purchased with electrical materials. And, another financial assistance worth P3 million this year is allotted to DASURECO to continue the implementation.

Hedcor and DASURECO concurred to utilize the financial assistance in procurement of house wiring and service dropping materials of the existing household-beneficiaries of the Sitio Electrification and Barangay Line Enhancement Program, a rural electrification program of President Benigno Aquino III. In line

with Aquino's administration, Hedcor lauded its concern for the welfare of the people of Davao del Sur through these projects.

DASURECO general manager Engr. Godofredo Guya said they requested Hedcor to convert their electrification project this year to house wiring from building up distribution lines after they received the requests from their recipients to avail free electric wiring.

In 2011 and 2012, Hedcor and Dasureco agreed to build lines to communities that have no access to electricity. Among the 15 recipients of the project are Sitio Campo Marawer in Barangay Kapatagan, Digos City and Sitio Tudaya in Barangay Sibulan, Sta. Cruz.

DASURECO is the power distribution utility of Davao del Sur, covering 14 municipalities and a city. Davao del Sur is host to the Hedcor-owned 42.5-megawatt run-of-river Sibulan hydropower plants and its ongoing construction of 13.6-megawatt Tudaya hydropower project.

Hedcor is the largest developer of run-of-river hydropower plants in Luzon and Mindanao and continue to expand in Visayas. A total of 19 plants are now generating with installed capacity of 155 megawatts.

### Hedcor's Tudaya hydro hits 1M safe working hours

The ongoing construction of the 13-megawatt Tudaya Hydropower Project of Hedcor, Inc. in Davao del Sur has already accumulated one million safe work-hours, a year after construction began.

With its partner JV Angeles Construction Corporation, the project attained this safety milestone, a clear demonstration of extraordinary teamwork and strong commitment to safety.

"We have reached this endeavor because of everyone's effort of making themselves secure and safe. We prioritize the safety and welfare of everyone," said Hedcor Vice President for Business Development Gregorio Jabonillo.

Hedcor Tudaya, Inc. started the project's construction last August 2012—with the plant expected to be operational next year—and since then, no lost-time accident has been recorded at the plant. A lost-time accident is defined as an incident that resulted in a fatality, permanent disability or the loss of at least a shift or a day of work all of which were conquered.

Situated in Sta. Cruz, Davao del Sur, the Tudaya Hydropower project is expected generate 76.5 million kilowatt-hours every year via a run-of-river scheme which naturally harnesses water from the nearby Sibulan River and its tributaries to generate clean and renewable energy.

### Hedcor launches 14-MW hydro plant in Mt. Province

AboitizPower subsidiary Hedcor Sabangan, Inc. officially launched last June 18 its 14-megawatt Sabangan Hydropower Project, which is the company's first venture in Mountain Province, at the Sabangan Municipal Grounds. The event was led by Hedcor President and COO Rene Ronquillo and attended by representatives from both government and non-government agencies including Governor Leonard Mayaen.

"We are here to stay and grow with the community. Hedcor is committed not only in maintaining its leadership in the field of run-of-river hydropower, but also to improving the lives of the residents of our host communities," Hedcor's President and COO Rene Ronquillo said in his speech.

Governor Mayaen affirmed, in turn, their local government's endorsement of Hedcor.

"Because of the good history of Hedcor, the LGU of Mountain Province is in full support of its hydropower project in the community. We are also hoping that this project is the start of more projects in the province," he said. Mr. Ronquillo, Gov. Mayaen, Sabangan Vice Mayor Joseph Bernandez, and Namatec Brgy. Captain Julius Licayo joined together in a ceremony to signify lasting ties between the company and community as they left their handprints on a cement tablet, which will later be placed at the constructed powerhouse. Meanwhile, Hedcor's VP for Business Development Boy Jabonillo and VP for Engineering and Construction Chris Sangster unveiled the perspective drawing of the Sabangan powerhouse.

The ceremony also welcomed representatives of local and national level organizations and government agencies, namely the Department of Energy, Department of Natural Resources, National Grid Corporation of the Philippines, National Commission of Indigenous Peoples, and Mountain Province Electric Cooperative.

Members of indigenous tribes in the community also did not pass up the opportunity to witness this milestone event in their province. Leaders of indigenous peoples shared and

reiterated their gratitude for choosing Sabangan as the project's host.

The Sabangan hydropower plant utilizes a run-of-river scheme that will harness the waters of Chico River. The project will have a total installed capacity of 14 MW that is expected to produce a total of 55 million kWh of clean and renewable energy per year. This is the company's answer to the government's thrust towards increasing the renewable energy portfolio of the country.

The community will benefit from the project through its corporate social responsibility focus on education, health, safety, environment, and livelihood. Local residents will have access to job opportunities during the construction phase and will be prioritized in the hiring process once the plant becomes operational. The host communities, including barangays and the tribal community, will also receive shares from the generation sales of the plant.

The hydro plant is expected to be operational in 2015.



### UnionBank Mobile Money Cash Management wins BPA Trailblazer Award

UnionBank's strategic partnership with Globe GCash to enable financial inclusion among microfinance borrowers exemplifies the Bank's values of elevating lives and fulfilling dreams through smart banking. More than 70% of Filipinos continue to be deprived of formal financial services mainly due to widespread poverty and geographic barriers. The Bank's Mobile Money Cash Management service enables microfinance institutions to process and monitor loan collections and disbursement in unbanked locations using mobile money technology.

The pilot project with Tulay sa Pag-unlad, Inc. (TSPI), the third largest micro-finance institution (MFI) in the country, started last October 2011. It began with a group of borrowers, whom they call "Nanays", in Sta. Elena, Camarines Norte. A typical Nanay would borrow P5,000 to P10,000 for six months to pay for additional inventory of a small livelihood

or to pay for her kids' education. Every week, a group of Nanays called a center would pool their loan amortization payments. Then two representatives from the center (usually the center chief and treasurer) would carry around P12,000 cash, spend almost 2 hours and P400 transportation cost — to reach the nearest rural or commercial bank to pay. The two Nanays not only expose themselves to the risk of being robbed, they also lose half a day that they could have spent selling goods and making a living. The existing loan payment process is detrimental to the mission of poverty alleviation; and the efficiency needed for MFIs to grow and reach more people is not achieved.

The MMCM solution equips individual borrowers with GCash wallets such that instead of traveling 2 hours to the next bank branch, Nanays can simply load (cash-in) their wallets at the nearest accredited outlet and pay in real time from their phones. Receiving their loan proceeds

via GCash keeps the funds safe and secured with a PIN (personal identification number) similar to a debit card. With GCash, a Nanay can pay bills, send money, buy load, and receive remittances. In the one and a half years of implementing the project with TSPI, over 100,000 borrowers have subscribed and over P1 billion worth of transactions were made through the system. The solution is expected to be fully implemented to the rest of the 300,000 TSPI borrowers by the third quarter of the year.

The mentioned difficulties are not unusual in the microfinance community; these are, in fact, widespread and prevalent. This opens up more opportunities for UnionBank to enable more communities, elevate more lives, and fulfill more dreams. While this recognition from Bank & Payments Asia caps off the dedicated work that UnionBankers have put in to complete the development and pilot; this only marks the beginning of an exciting journey ahead.

# Aboitiz Foundation aids in relief operations in Taguig, Laguna, and Cainta

To date, the Foundation has reached out to some 50,000 students across the country with 597 classrooms. These facilities are complete with tools and equipment such as desks, blackboards, and fixtures that will help improve the students' academic performance.

Mr. Carpio also noted that the Foundation is also actively encouraging learning in Science, Language and Computer through the donation of science and speech and the refurbishment of computer laboratories and stipend support to Information Technology teachers.

The facility, built in 1995, serves as offshore shelter for members of the Philippine

Navy, Philippine Coast Guard, and local law enforcement who spend months patrolling the Tubbataha Reefs marine park. Years of exposure to the elements have caused the ranger station to become rundown.

Once completed, the modernized Tubbataha Reefs ranger station will also have a research building for up to eight marine biologists, library, visitor center, and

a museum showcasing the marine park's rich biodiversity.

Declared a UNESCO World Heritage Site in 1993, Tubbataha Reefs is a marine protected area and home to one of the world's most remarkable underwater terrain and marine biodiversity. It has also been included in the Ramsar List of Wetlands of International Importance in 1999.

### **Cebu Normal University wins 2nd Green Fashion Revolution**

Ten Cebu Normal University (CNU) students proudly displayed their passion for a better world—through fashion design—as they bagged the top prize at the 2nd Green Fashion Revolution fashion show held at the SM City Cebu Trade Hall last August 3.

Several Aboitiz team members volunteered to pack relief goods at the Aboitiz Corporate Center and headed to the barangay to distribute them on June 12. One hundred ten families received relief packs containing ready-to-eat canned goods, biscuits, and water.

## Pilmico donates P25M classroom building in Sta. Elena, Iligan; largest CSR effort to date

Pilmico Foods Corporation turned over last August a 24–classroom school building in Iligan City, the company's largest corporate social responsibility (CSR) project to date.

The P25-million school building is located in Bayanihan sa Iligan Village in Barangay Sta. Elena, a 15.9-hectare relocation site that is also home to 1,711 families displaced by Typhoon Sendong two years ago.

"Students from barangays in Iligan City that were hit by Typhoon Sendong no longer have to worry about having a place to stay or traveling far only to study in congested classrooms," Sabin Aboitiz, Pilmico President and Chief Executive Officer, said.

After flash floods washed away and damaged schools in Barangays Hinaplanon, Santiago, Sta. Filomena, and Bayug Island, students were earlier forced to attend classes in already crowded schools in other barangays. In some schools, fixtures and furnishings were used by evacuees. Further, when the students and their families relocated to the Bayanihan sa Iligan Village, the students had to travel about 10 to 12 kilometers daily just to be able to go to school.

"This underlying need to provide convenience and comfort to the students is the reason Pilmico is building this school. The quality of education that the children will be getting is at stake if this is not remedied." Aboitiz said.

"We are doing this to show our commitment to Iligan, the place we have been calling home for more than 50 years," he added.

The school building project was constructed and donated in partnership with Aboitiz Foundation, Inc., the social development arm of the Aboitiz Group.

SEZ selects 10 Grade 7 high school students every year to be a part of its scholarship program. A screening process is done for applicants with the following criteria: 1) be an honor student graduate of a public elementary school; 2) have a general average of 85% or higher; 3) should not have a grade below 85% in the fourth grading

period; and 4) be enrolled in public high school.

A scholar must maintain an 85% grade average as a freshman, 86% as a sophomore, 87% as a junior, and 88% as a senior to be retained in the program.

#### SNAP holds CSR forums for Luzon stakeholders

Other highlights of the forum were plant operations updates from SNAP-Benguet and SNAP-Magat's assistant vice presidents and plant managers Emmanuel Lopez and Wilhelmino Ferrer. AboitizPower's community relations officer Wesley Briola gave a reorientation on the process of availing the Energy

Regulation (ER) 1–94 fund, which requires power generators to remit to government one centavo per kilowatt–hour of their electricity sales. These funds are dispensed by the Department of Energy and used for projects on electrification, reforestation, and livelihood.

SN Power's country representative Rodolfo Azanza also gave an update on SNAP's greenfield development program, SNAP's business development arm. The program aims to expand the company's renewable energy portfolio by identifying and developing sustainable hydroelectric projects.

The annual CSR forum series is a venue of SNAP and its stakeholders to discuss, among other things, direct benefits, new projects, and updates on the company's corporate social responsibility program which is jointly implemented by SNAP and its host communities.

## Hedcor, WeatherPhilippines donate AWS in Mt. Province

Mountain Province now enjoys localized weather forecasts through its own automated weather station (AWS) provided by Hedcor, Inc. and Weather Philippines Foundation, Inc. The unit was turned over to provincial government last May 29 and installed within Sabangan Municipal Hall.

Present during the event were members of the Sangguiniang Panlalawigan and Chief of Police Joaquin Nacnas, and Municipal Budget Officer Robert Beke.

"It (AWS) will improve communications among national agencies," said Mr. Beke who commented on the confusion on weather updates experienced by people during a typhoon.

The weather station can determine rainfall. humidity, temperature, and wind direction.

Powered by solar energy, it requires no electricity consumption and, during cloudy days and evenings, the station has a built-in battery ensuring its operations 24 hours a day. The device will send information to PAGASA and its readings will be automatically available through the Internet.

"It is most advantageous in the field of forecasting because of its advanced technology," added Mr. Nacnas.

WeatherPhilippines is set to install 1.000 automated weather instruments across the country by the end of the year. Each weather station can transmit weather information to



weather station (AWS) to representatives of the Sabangan municipal government in Mountain Province. The AWS will offer localized weather reports of the area freely available through the Internet and mobile phones.

neighboring weather stations nearby and the new Sabangan unit will soon be part of the distribution of weather data in the Philippines.

Caballero also discussed weather.com.ph, WPF's online portal that provides free localized weather information presented in an easy-to-understand format.

This year's Green Retail Agenda focused on disaster risk resilience, logistics programs, and

The units were turned over to SNAP-Magat on July 23 in Isabela in an event attended by SNAP-Magat Assistant Vice President & Plant Manager Wilhelmino Ferrer, SNAP Vice President & Chief Corporate Services Officer Mike Hosillos, WPF General Manager Celso Caballero III and Aboitiz Power Corporation Assistant Vice President for Corporate Branding & Communication Ria Calleja.

One AWS will be installed near the entrance of the Magat Dam spillway at the border of Ramon, Isabela and Alfonso Lista, Ifugao, while

the second AWS will be placed upstream near Bato Perry bridge in Bayombong, Nueva Vizcaya.

"The installation of these units opens up great opportunities to help empower local communities in disaster management," said Hosillos. He added that SNAP is developing a program to help disseminate the free information to the grassroots level for use in livelihood or business, as well as enable local government units to develop plans and action on disaster management based on localized data.

The AWS is capable of determining rainfall, humidity, temperature, pressure, solar radiation, and wind speed and direction. It is powered by solar energy with back-up battery, which eliminates electricity consumption and transmits data automatically every 10 minutes via mobile communication technology. The information from these weather stations are presented in a format that are easier to understand and can be accessed for free via weather.com.ph.

# Group-wide tree planting participants increase, draws 3K team members

The chosen site is a 175-hectare protected wetland with trees and mangroves serving as a haven and stopover for at least 5,000 indigenous and migratory birds taking the East Asian-Australasian Flyway every year to flee the harsh winter.

Other locations for the tree planting were Mak-Ban (Laguna), Tiwi (Albay), Guba (Cebu), Marilog District, Talomo, and Marilog (Davao), Dimpatoy Watershed (Cotabato), Ambuklao and Binga (Benguet), Magat Watershed (Ifugao), Maco (Compostela Valley), Nasipit

and Capas (Tarlac), and Sta. Elena (Iligan).

"Given the impact that such a small patch of land has on the planet, our sense of responsibility as its caretakers and the consequence of this effort becomes even more critical. We as Aboitiz team members, individually and collectively, need to remain dedicated to contributing our resources and talent to ensure that natural ecosystems like this one continue to support their ecological functions.," said Erramon I. Aboitiz, CEO of Aboitiz Equity Ventures, as he thanked team members for their support of the annual activity.

# Jump-starting the Cleanergy Center project

When the MakBan Geothermal (MakBan Geo) complex was turned over to APRI in May 2009, it came with a Science Centrum, as it was called, where geological specimen and geothermal equipment were displayed in order to showcase the plant.

In 2010, top officers of AboitizPower then decided it was time to establish a venue to:

- Educate students (of all ages) on energy in a fun and exciting manner,
- Build awareness for our AboitizPower and Cleanergy brands, and
- Establish ourselves as experts in the power industry as we promote science and technology.

The Science Centrum came out as the ideal location for such a place of learning given its proximity to Metro Manila and also it being within a complex that generates electricity using

a renewable resource. Of the old Science Centrum building only the foundations and roof remained in the plans for the new one. Upon it would rise a more iconic yet practical space. It would have 500 square meters of exhibit area, an amphitheater seating 70, a small VIP receiving area or meeting room and a roofdeck that would provide sweeping views of Geothermal Plants B and C, the immediate surroundings and new administration building. The dome on top of the amphitheater would be clad in aluminum and rise 14 meters up, creating for a memorable yet modest structure to highlight the important of the Center.


